RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

In consideration of participating in classes, special events, and/or birthday parties at Cypress Academy I represent that I understand the nature of this Activity and that I and/or my child(ren) are qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue my and/or my child(ren)s participation in the activity.

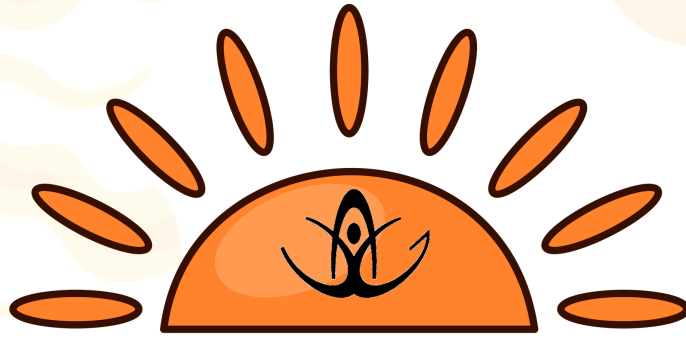
